CLOSE ENCOUNTERS

Halley's Comet should become visible to the unaided eye in December, 1985, low down in the evening sky in the west. By the end of January it will have disappeared as its orbit takes it around behind the sun.

It is due to reappear late in February when it will be visible just before the sun rises. As it comes closer to Earth, the tail becomes brighter as it climbs higher in the sky each morning.

April ll will be the prime viewing time for the comet as then it shall be closest to this planet. Rising just after sunset, and setting just after the sun rises, it will be directly overhead at midnight.

April should also offer a spectacular display the tail will appear to swivel from the NW to the SE. This will be due to the geometry of the Earth's orbit, and that of the comet's.

The comet will best be seen against a dark sky, and away from urban lights. A full moon in late April is due to be eclipsed, so as the moon darkens, the comet will appear to brighten.

After April the comet moves north and gradually fades, and by the end of June will have disappeared from view - until 2062. (Information supplied by Vince Ford, ABC Science Show - cassette on his talks are available from the ABC shop).

PRIVATE HUTS IN CRADLE MOUNTAIN-LAKE ST CLAIR NATIONAL PARK

A terrible threat is looming for one of Australia's best known national parks. The Gray Government in Tasmania has asked its National Parks and Wildlife Service to call for tenders to build private huts in Cradle Mountain-Lake St Clair National Park. They will be operated and built by commercial tour operators for their exclusive use. If they go ahead they will be a dangerous precedent for all of Australia's national parks.

Objections to the huts are:

- They will damage the park's delicate alpine environment, and are incompatible with the National Park Concept.
- If visitor limits are eventually put on the park the huts and their clients may displace independent walkers and visitors.
- The huts may be dangerous if they encourage people on commercial trips to walk in bad weather.
- 4. Thew huts are being built before any management plan for the area has been compiled.
- People can already see the park on a commercial walking tour, there is no need to add private buts to the tours.

The huts will have to be approved by the council that federal-state ministerial administers Tasmania's world heritage area which includes Cradle Mountain-Lake St Clair National This means with enough pressure the Park. Federal Government could stop the huts. bushwalkers should write to the Federal Minister for Arts, Heritage and Environment, Barry Cohen (Parliament House, Camberra 2600) and the Tasmanian Minister for National Parks, John Hobart (Parliament House, expressing their opposition to the huts.

FBW MEETS CARR

For the first time in over five years, the Federation has managed to meet with a Minister of the Crown. The meeting with the dynamic new Minister for Planning and Environment, Bob Carr, took place on 17 July, 1985, at the Minister's offices in Macquarie Street.

Representing the Federation were Gordon Lee (President), Jim Callaway (Treasurer), Hugh Paterson (Ramblers), John Berry (CMW) and Roger Lembit (SUBW). Ted Weir, Acting Assistant Director of NPWS was present to advise the Minister.

Mr tarr gave the delegates almost I hour of his time and was receptive on all issues raised. He seemed genuinely concerned at the points made by the Federation representatives, who felt that the meeting achieved a great deal. Follow-up will be needed to ensure that the progress made at the meeting can be built upon over the coming months.

The main topics for discussion and the outcomes are summarised below.

- Off-road vehicles. Concern was expressed at damage being caused in many natural areas by four-wheel drives and trail bikes. The Minister agreed that use of such vehicles should be restricted and outlined the action the Service was taking to achieve this.
- Policing in National Parks. A wide range of incidents in Parks were discussed. The Minister pointed to the severe financial problems of the Service and the need to widen support for National Parks to justify increased funding. It was pointed out that bushwalkers who observe illegal activities (eg dogs in parks, use of off-road vehicles on closed roads, removal of bush rock or timber) should contact the local office of the Service as soon as possible.
- Insurance for Federation Activities. The anomaly that groups who contacted the Service about intended walks were required to take out substantial liability insurance whilst those who failed to notify the Service avoided this requirement was raised. Ted Weir pointed out that the Service could be legally responsible for all incidents in parks due to the common law principle of "duty of care" and needed to cover itself against possible claims.

The Federation will seek to investigate this matter further and if necessary make representation to the Attorney-General.

- Rationalisation of National Park Boundaries. Federation pointed to a large number of cases where park boundaries prevented proper management of parks and urged the Minister to look closely into these matters. The Minister indicated that improvements to boundaries of some parks would be announced over the next 12 months.
- Promotion of Bushsports. The Minister undertook to make representations on our behalf to the Minister for Leisure, Sport and Tourism, Mike Cleary, regarding the promotion of the Federation's Bushsports programme.
- Activities of Commercial Operators. The matter of the practices of commercial adventure travel operators in National Parks was raised, Federation expressed interest in assisting the Service to draw up a set of conditions for commercial operators and raised the matter of operators acting in an improper fashion. The Minister pointed out that the growth of commercial operations should be encouraged as it served to increase the "National Parks constituency".

WOODCHIP CAMPAIGN HOTS UP

Conservation groups in NSW have launched a full scale campaign to halt the continuing devastation of the State's forests at the hands of the woodchip industry. The groups claim that the timber in thousands of hectares of forests and wild river catchments is being set aside for the chippers before export to Japan.

They point to a secret expansion in the woodchip operations on the North Coast and proposed extensions into the Bateman's Bay forest regions as being examples of the woodchip industries' insatiable appetite.

A number of National Park proposals are threatened by woodchipping including the northern end of the Genoa wilderness between Nungatta and Nalbaugh National Parks, south of Bombala.

The groups are forming an alliance to "Give the Chip the Chop". Any offer of assistance is welcome. Donations should be made to the "South East Forest Appeal, P.O. Box 1875, Camberra City, ACT, 2601.

BUSHWALKERS SEARCH & RESCUE

Bushwalkers' Search and Rescue is an independent section of The Federation of Bushwalking Clubs (N.S.W.). It was established in 1934 as a self-help organization for assisting lost or injured fellow bushwalkers but has evolved to become a community service ready to assist any persons in difficulty in bush areas.

The Committee, of Bushwalkers' 5&R, is the guilding organization for co-ordinating the vast skills of the 'bushies' to help the N.S.W. Police. Bushwalkers S&R is therefore a member of the Police recognized rexcue organization, The Volunteer Rescue Association of N.S.W. (V.R.A.).

The V.R.A. provides additional resources from other rescue squads and insurance cover for all official activities (practices and callouts).

Bushwalkers' S&R is not another club; active membership is a pre-requisite for participation in S&R. S&R's role is to provide training in the techniques of search and rescue, as well as education in bush safety, at the three S&R practices held each year.

This role places some demands on the committee members' time but this is freely given to keep the best possible people. i.e. bushies, doing bush search and rescue.

Ali keen bushwalkers should be aware of the potential dangers of their sport and consider the difficulties of finding or rescuing their friends or themselves from the remote areas they visit. Your regular attendance at S&R practices is essential to keep Search and Rescue operational: 'just in case you might need us'.

Once you have attended a practice make sure your Club phones contact persons for S&R). know of your availability; anytime, next day or weekends only. Always keep the following phone numbers in your rucksack (you just can't trust someone else to remember them).
