## Alex Allchin: Crown Lands Roads Reserves Sell Off Issue

Road reserves are: A roughly road sized gap between two properties, a reserved space for building access roads, if needed. Provide legal access routes to national parks and natural areas for bushwalkers.

Sometimes landholders don't like people using the road reserves.

Landholders need to lease the space currently because it often bisects their land.

Landholders can apply to have road reserves that cross or border their land closed, so they can purchase them.

The road reserve closure will be advertised for 28 days before it can go ahead.

Alex Allchin has signed up to receive email alerts. He receives an email if any road reserve closure application comes in.

Steps for checking road reserve sell off application:

Check website (Link in Power Point Presentation: <u>www.roads.crownlands.nsw.gov.au</u> ).

Check six maps for location: https://maps.six.nsw.gov.au/

Check off whether or not it's important to bushwalkers and make a submission about this if it is

How many submissions are needed to cause a road not to be sold?

#### Mitch Isaacs: Road Reserves

Processing time used to be months or even years to process the road reserve sell off requests.

Recreational fishing access routes are monitored. NPWS monitors the Road Reserve Sell Off applications, but will not know what is important always. It is important for bushwalkers to write quick submissions about why a given road reserve (to potentially be sold) is important to them. That way NPWS and Crown Lands will know and be able to ensure the sale does not proceed.

## Mitch Isaacs: AAAS Update

We have only joined the negotiations recently because originally we thought they would be more of an abbreviated amalgamation of state standards. Thinking it was more of a Bushwalking Australia matter if anything, we stood back. Unfortunately, we were notified that clubs and state peak bodies were concerned about the standards becoming too large, unwieldy and complex, unpleasant and unhelpful for bushwalking clubs to adhere to. That's when we began to take a more active role in the AAAS development.

<u>Background:</u> 1.5 years ago it was proposed that a new set of national standards be produced. BNSW was under the impression initially that these new standards would be similar to the NSW standards, which we had endorsed. However our member clubs drew our attention to the standards more recently, as they were unhappy with the direction the AAAS negotiations seemed to be taking.

The new draft standards were over 3 times longer than NSW standards in just the first chapter.

Bushwalking Victoria has called for an exemption for bushwalking clubs from the AAAS.

BNSW thinks it's better to have the AAAS apply to clubs and support better safety for clubs without inhibiting activities.

BNSW recommends to the AAAS development committee that the risk management guidelines for NSW standards as a model for shorter standards that are more workable.
