In the 'Getaway Extra' of the 8th September Herald, the editor invited all wilderness users to put forward their views on wilderness and its management. The accompanying article was concerned mainly with the Helman Report's views on wilderness. On the Helman Report's propositions on wilderness, the Herald says :

"Many of these propositions furnish a philosophical battleground for conflicting opinions on what kinds of recreation should be allowed in wilderness areas. "Already different groups of outdoor

clubs are waging a propaganda war against one another over the issue. Bushwalking clubs, for instance, are actively opposing the use of our four wheel drive vehicles in many wilderness areas.

"The N.S.W. Federation of Bushwalking Clubs isn't simply campaigning for special privileges for its members. It is also re-defining its own activities and advocating limitations in some areas".

It is good to note that apart from the NPWS, Federation is the only wilderness use body to be named in the article.

The invitation is an ideal opportunity for bushwalkers to have their views put across through the newspapers. The editor hopes for a 'bushlands debate'. Perhaps through this a 'bushlands debate'. 
