With this investment the National Parks and Wildlife Service plan to develop a network of a tracks and trails offering short to medium walks and cycling opportunities supported by visitor hubs offering facilities for day use and overnight stays including campgrounds, picnic areas, car park and toilets. The project includes a 4-day walk from near Uki to Minyon Falls, designed to provide the walker with the ultimate rainforest experience.
