#### **Present**

1. Members of the Bushwalking NSW Committee and delegates of various BNSW clubs, additional members and visitors as per the attendance list above.

The meeting commenced at 7pm with David Bell as chair.

2. The EO and Chair welcomed members and visitors at 1900 and in the meeting preamble a number of clubs reported on their activities. The Chair declared the General Meeting open at 1930, and welcomed James McCormack.

#### **Previous Minutes**

4. The Chair moved that the tabled minutes of the General Meeting of the 16th Feb, 2021 Bushwalking NSW Inc General Meeting be accepted.

Seconded and approved.

#### **Guest Speaker**

5. James McCormack, Editor of Wild Magazine, spoke on the topic: Luxury Lodges = Wilderness Lost. James first presented this topic in Wild Magazine Issues #178 and #179. Some points shared (not exhaustive):

- The goal is no private infrastructure in national parks. It isn't no business. Just no private infrastructure. It's not about being anti-business, nor anti-luxury, and it's not about being pro- or anti-huts. These developments aren't just huts. They're huge.
- Private accommodation for walkers within national parks is at the core of our worldviews such as: private/public, rich/poor, development/wilderness etc.
- Cost to stay in luxury accommodation around \$3,000 for 3 nights.
- This phenomenon of accommodation being built in National Parks nation-wide.
- Impacts on equality of access:
  - o Exclusion of many, purely due to economics
  - Exclusion of campers
  - Numbers limited it seems to increase exclusiveness
- This is the loss of access to public land
- Largest issue is loss of wilderness can't have a wilderness lodge once the lodge is there, it's no longer wilderness. Visual and sound impacts.
- Loss of wilderness suits the target demographic: "52-year-old single female".
- Instead of taking these clients to appropriate locations; it's to make locations 'appropriate' to his clients by removing wilderness.
- Huge servicing required = helicopters = noise = loss of wilderness
- Other issues:
  - land clearing
  - o greywater waste clogged and inadequate, killing myrtle forest downstream
  - o hardening of trails remove mud, add steps, more duckboarding,
  - Loss of serendipity, spontaneity and freedom
- the Light to Light Great Walk is only one of more than 100 projects the Government has identified with the aim of generating an income from national parks. Nine moneymaking projects have been given "priority funding" from \$80 million allocated
- The NPWS has declined a freedom of information request for the details of the other 90 or so projects under consideration
- The tragedy is that many of these developments are paid for by tax dollars. The public pays their taxes, and some of those tax dollars are then doled out to developers so they can alienate that same tax-paying public.
- Sums are eyewatering \$3 \$25 million. Some without environmental impacts assessments, nor business cases made.
- Reasoning for developments is jobs but more would be employed with porters, camp crews, cooks ... without the huts and hot showers.
- Jobs will be lost by outdoor guiding companies, and then on KI, and around Ben Boyd NP, many B+Bs and accommodation providers who will lose out clients to these lodges. And transport service companies etc etc

- Government is not receiving good returns either. At Malbena 10ha of wilderness (and the chopper flight paths covering thousands of hectares), is being flogged for as little as \$20/week. It's hard to see the value spending \$25 million, to gain say, \$100K in licensing fees.
- National parks already pay their way and contribute \$19.5 billion annually to NSW's economy.
- These developments grant monopoly rights to private companies. No competition from other lodges. Camping the only competition, hence the push to close campsites.
- Marketing is already done for them. National parks are a brand.
- Showers are fundamental to the lodges' marketability. But they're not appropriate in the wilderness. Soaps, shampoos, cosmetics, etc. Plus gas shuttled in by helicopter.
- Commercial tourist infrastructure doesn't have broad community support. 90% were strongly opposed to Falls to Hotham Alpine Crossing. Only 3 in 1,346 submissions supported Tasmania's Lake Malbena/Hall's Island development.
- Projects getting through emasculated national parks bureaucracy, replaced by tourism sector. But there's even been a split in the Tourism Industry Council of Tasmania, with some members revolting against the push for tourist projects within parks.
- Political influence of tourism industry lobbyists is immense.
- Lodge developments allow politicians to seem like they are 'doing something'. Far harder for a politician to drum up interest in a media release saying that within any given park, nothing has altered in decades.
